### **Camp Pepin Scholarship Form**

Thank you for your interest in Camp Pepin. It is the policy of the Red Wing YMCA and Camp Pepin to provide services to any person who desires to participate, regardless of their ability to pay the standard fee. These funds are made available through contributions to the YMCA from a variety of sources.

Financial assistance eligibility will be determined based on a thorough review of the application, and, if necessary, a personal interview with the applicant. Subsidies will be granted to the extent funds are available.

The YMCA and Camp Pepin believes a strong sense of ownership and pride is developed if the financial assistance recipient has contributed to the cost of their YMCA involvement. Therefore, applicants are asked to pay a portion of the fee for the requested service. Payment plans can be set up.

### **ALL APPLICATION RECORDS WILL BE KEPT CONFIDENTIAL**

#### **Application Procedures:**

Proof of income must accompany all applications:

- 1.) Last pay stub **and**
- 2.) Last year's tax return **and**
- 3.) If you receive assistance from Goodhue or Pierce County those documents can be submitted stating how much you are paid monthly.

Applicants have an opportunity to provide information on any extraordinary expenses and/or situations which may pertain to their eligibility for financial assistance. **Please DO NOT email or fax any scans or financial information to us for security reasons.**

Please complete the camper registration form and financial assistance form. A financial assistance form must be submitted every year.

**All applications will be reviewed after our annual fundraising event.** The fundraising event is a great opportunity for all campers to earn either part of their way to camp or earn their entire way to camp.
